Management Change Announcement

The Waynesboro Country Club Board of Directors has selected Mr. Steven T. Glossinger, CGCS from Towson, Maryland for the new combined role of General Manager, Club House Manager, and Golf Course Manager/Project Manager for the Club. Steve has served as Golf Course Manager/Project Manager at Caves Valley Golf Club in Owings Mills, Maryland for twenty-one years. Prior to Steve's tenure at Caves Valley, he held a similar position at Oakland Hills Country Club and previously to Oakland Hills, the General Manager/Golf Course Manager/Project Manager for Point O' Woods Golf & Country Club, in Bent Harbor, Michigan.

Steve has been the Major Championship Host Superintendent for the U.S. Open, Senior Open, Senior Tour Players Championship, Western Amateur for eight years as well as Women's and Men's NCAA Championships. Some of his distinguished recognitions have included being chosen as one of the "Top Ten Superintendents in the World" by the *Golfer Magazine*, assigned by *Golf Digest* as a Golf Digest Rater Panelist, and awarded the "National Turf Manager of the Year" by the Toro Company.

His most recent major golf course designs and improvements have included the renovation of golf holes, tees, bunkers, as well as the drainage system at Caves Valley Golf Club with Tom Fazio, Project Manager. In 2016 Steve led his Caves Valley crew through a complete re-grassing of all the greens during the off-season without the usual full season closure that most clubs experience.

During his career, Steve has mentored more than 30 Assistant Superintendents now employed as Superintendents at top clubs across the country as well as 62 College Students in the field of Agronomy and was recognized for his efforts by Michigan State University who awarded Steve an honorary degree in 2015.

Steve holds a Turf Management Degree from Andrews University, Berrien, Michigan as well as Honorary Degree in Turf Grass Management from Michigan State University. He is a frequent guest speaker at Michigan State University, Rutgers University, and the Penn State University.

"A LETTER TO THE MEMBERSHIP"

BOARD OF DIRECTORS

Dear WCC Members:

We hope by now you have seen the positive changes in the Clubhouse and Golf Course that have occurred within the past week. We are pleased to report that we are fully operational in all aspects of club business with noticeable improvements throughout the organization.

Along with these changes we want you to know that we fully understand your concerns during this leadership transition and hope to reassure everyone regarding the future operation of the Club. We promise you that no one wishes that a person be removed from employment at WCC as we all care for his or her wellbeing however, the business decision to go in another direction for the management of WCC, although difficult and heartbreaking for all of the Board Members, was supported by a large majority of this committee. We feel a deep obligation to be thoughtful stewards of the Club, and therefore, kept this at the forefront of our decision-making process. Your Board of Directors concentrated primarily on the long-term viability of WCC while simultaneously focusing on the fiscally responsible decisions that needed to be made despite the difficult nature of such actions.

As with any organization or private club that goes through a similar transition, there are rumors and misinformation shared among its employees and members. Some thought that the BOD acted without due process, however since October 2017, we have offered recommendations, completed evaluations, provided tools and other resources for our managers to make the constructive changes to various aspects of our Club operation. It was disappointing to the Board that our assistance was not accepted and the recommendations not implemented. In addition, we relied on good data as well as industry benchmarks and standards in making our business decisions and as difficult as it was, put our personal emotions to the side in order to focus on the wellbeing of WCC.

Some have mentioned that the move was sudden and the managers were not given a fair chance to address the concerns of the Board. We can assure you that our repeated attempts to work with these individuals were well thought out and implemented over a reasonable period of time, and as I have pointed out, their actions landed well short of the Board's expectations. This past year we engaged a high profile national golf course management company to make an extensive evaluation of the Golf Course Operation resulting in numerous recommendations as well as a proposal to manage the Golf Course. This management company would have been responsible for staffing and required our current employees be interviewed as part of the transition process. There was no guarantee that our current staff would have remained on board had we pursued this route. This company also evaluated the Clubhouse Operation despite not being part of our initial request. At the June BOD Meeting this proposal was narrowly defeated.

Mr. Steve Glossinger was also invited this spring to consult with the Golf Course Operations and after the BOD Decision not to contract the management company, he contacted me personally and offered a Golf Course Management Plan along with a proposal to manage the entire Club Operation. The reason Steve offered the proposal is the fact that he was aware that the BOD was exploring options and after a year and a half of consulting, he was hungry to get back to what he loves to do. Based on his excellent resume, references, and willingness to offer his expertise and talents to help our Club, I could not in good faith ignore this proposal and not share it with the BOD. An interview by the Board was scheduled prior to the August BOD Meeting. Unfortunately, there are a number of untruths being shared about Steve's work record in an effort to undermine his efforts to enact positive change. Likewise, with the new employees, there is a dialogue as to their legal authority to work in the United States, which is unfortunate. In order to assure the membership that all hiring is on the up and up, I have registered the WCC with the Department of Homeland Security and am now qualified as an administrator for the E-Verify Program. I personally confirmed the employment qualifications for each of our new staff members.

We have appreciated and respected the comments from the Membership and I would be more than happy to discuss any specific questions that you may have in reference to the BOD's decision. Please feel free to call my cell phone at 717-729-7158 at your convenience.

WCC Hole #1 Tee Box Renovation: On Tuesday, September 3rd the Arborvitae Trees on the Tee Box will be removed and the site will be prepared for the construction of a decorative wall, lighting, and new landscaping to accent the Hole #1 Tee Box. The design change will enhance the air flow and sunlight to the tee box and improve the visibility for the golfers and staff. Lucas Byers, Creative Hardscapes & Lighting will be coordinating the project and Steve Beck has volunteered his time and equipment in the tree removal and site prep. Steve Glossinger's team will also be responsible for the tee box upgrades as well. All design aspects of this project has included the safety of the players on the practice putting green with the ball flight trajectory studies. This project is scheduled for three to four weeks and the Blue/White Tee Box will be moved to the Gold/Red Tee Box Location during the day. We are very pleased that the Tee Box Renovation will be underwritten by one of our Golf Member Families and a dedication will be planned for later this fall.

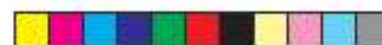
